

Introduction

This document is designed to support your organisation to implement and embed the principles of The Compact. It is recognised that every organisation is unique and that this document should act as guidance only.

It is recommended that this document be used in accordance with other supporting documents including the case studies provided.

What Is the Compact?

The Compact for West Cheshire is an agreement for the public sector and Community Sector to work collaboratively for the benefit of local communities. This agreement is designed to:

- Build upon relationships between all organisations within the public, voluntary, community and faith sectors for mutual advantage
- 🎋 Lead to improved partnership working
- 🎋 Create sustainable, quality services for all communities, and
- Recognise the importance of Community Sector organisations in terms of service provision, value to the economy, positive impact on well-being and quality of life, and promotion of volunteering and citizenship

The signatories to this Compact agree to treat each other with respect and to work together for their mutual benefit and, ultimately, to achieve the best outcomes for the residents of Cheshire West who use their services. Signatories of this Compact agree to the following key principles:

	Key Principles
Shared Purpose	All organisations are working towards a stronger future where we all play our part in thriving, caring, and sustainable communities.
Equal Partners	We achieve so much more together and there is more that unites us than divides us, taking a collaborative approach across organisations is vital to making a difference.
Involvement of All	Work with people, communities, organisations and those with lived experience at all stages when designing and developing services.
Partnership and Collaboration in Decision Making	We will work together to think creatively focusing on solutions rather than problems, we want our residents, communities and organisations to have the opportunities and resources to make a difference.
Keep it Local	Build strong local partnerships to maximise local strengths, support local suppliers and employment to retain wealth and jobs in West Cheshire.
Funding and Commissioning	Work together to support the commissioning of services to ensure that they involve and engage all communities that they affect. Ensure that the widest possible range of organisations can be involved in the provision of services.
Social Value	Focus on the common goal to have a positive impact on the community of West Cheshire through gaining additional value in how we deliver services.
Independence	Collectively acknowledge the differences between the Sectors that have agreed to this Compact and recognise that due to these differences, we as a collective are strengthened.

Implementation

Each organisation involved in the Compact has different responsibilities, governance and constraints. Implementation of the Compact will vary according to each organisation, the below table outlines some examples of how the principles could be applied with organisations empowered to decide how best to enact the agreed principles.

When signing the Compact, organisations should think about what the principles of the compact mean to them and set themselves key actions for each.
